LIMITED 3-YEAR WARRANTY

YOUNG CHANG NORTH AMERICA, ("YOUNG CHANG") warrants to the original consumer/purchaser that this product shall be free from any defects in material and workmanship for a period of two (2) years from the date of purchase. In addition, material and parts shall be covered for a period of three (3) years from the date of purchase.

If a defect covered by this warranty occurs during this two-year period (or within three year period for parts and material), return the product within such two (or three) year period together with a copy of your sales receipt or similar proof of purchase to:

A. The Authorized **KURZWEIL** dealer from whom you purchased it; the dealer will repair the defective product without charge for parts (3 years) or labor (2 years).

OR

B. The nearest **KURZWEIL** Authorized Service Center; the Authorized Service Center will repair the defective product without charge for parts (3 years) or labor (2 years).

The consumer is responsible for any costs incurred for the transportation of the unit to and from the **KURZWEIL** Authorized Dealer or Service Center. If the unit is too large for normal transportation to a Dealer or Authorized Service Center, Warranty Service may be performed on site, at the discretion of the **Kurzweil National Service Manager** or his designated subordinate.

This warranty does not cover damage or malfunction resulting from improper handling or abuse, accident, misuse, failure of electrical power, battery leakage, use on improper voltage or current, failure to follow normal procedures outlined in the User's Manual, use with other products not manufactured or approved by **YOUNG CHANG**, alteration, damage while in transit for repairs, repairs attempted by any unauthorized person or agency, or any other reason not due to defects in materials or workmanship. This warranty is void if the serial number has been altered, defaced or removed.
